## ARTICLE 1 - LEGAL PROVISIONS

## ARTICLE 2 - ACCESS TO THE WEBSITE

## ARTICLE 3 - WEBSITE CONTENT

## ARTICLE 4 - WEBSITE MANAGEMENT

Personal data means: all information about an identified or identifiable natural person; an identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier such as a name, an identification number, location data, an online identifier, or one or more factors specific to the physical, physiological, genetic, mental, economic, cultural, or social identity of that natural person.

The personal data collected on the website is mainly used by the administrator to maintain relationships with you and, if necessary, to process your orders.

## ARTICLE 7 - YOUR RIGHTS REGARDING YOUR DATA

Under Article 13 paragraph 2 sub b GDPR, everyone has the right to access, rectify, or erase their personal data or restrict processing concerning them, as well as the right to object to processing and the right to data portability. Any request for this must be accompanied by a copy of a valid ID, on which you have signed, and stating the address at which we can contact you. Within 1 month of the request being made, you will receive a response. Depending on the complexity of the requests and the number of requests, this period may be extended by 2 months if necessary.

## ARTICLE 8 - PROCESSING OF PERSONAL DATA

In the event of a breach of any law or regulation, of which the visitor is suspected and for which the authorities require personal data collected by the administrator, these will be provided to them after an explicit and reasoned request from those authorities, after which these personal data will no longer fall under the protection of the provisions of this privacy statement.

Non-anonymous Analytical cookies: to gain insight into visits to our website based on information about visitor numbers, popular pages, and topics. This way, we can better adjust communication and information provision to the needs of visitors to our website.

Tracking cookies: such as advertisement cookies intended for displaying relevant advertisements. Personal interests can be inferred from information about visited websites. With this, organizations can, for example, show targeted advertisements to website visitors. Tracking cookies enable the creation of profiles of people and treating them differently. Tracking cookies typically process personal data.

Specifically, we use the following cookies:

- Google Analytics anonymized (analytical cookies)
- Google Analytics (analytical cookie)
- Adobe (analytical cookie)
- Facebook (tracking cookie)
- Google Adwords (tracking cookie)
